COTSWOLD DISTRICT COUNCIL (“the Council”) in exercise of its powers under Sections 32, 35, 35C and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (“the 1984 Act”) and under the Road Traffic Act 1991 as amended (whether generally or in relation to the area of the Council) (“the 1991 Act”) and of all other enabling powers, with the consent of the Gloucestershire County Council in accordance with Section 39(3) of the 1984 Act and after consulting with the Chief Officer of Police in accordance with paragraph 20 of Schedule 9 to the 1984 Act, hereby make the following Order:-

**PART I
GENERAL**

Commencement and Citation

1. This Order shall come into operation on the **4th** day of **April 2022** and may be cited as the Cotswold District Council (OFF-STREET PARKING PLACES) ORDER 2018 (VARIATION) (NO.1) ORDER 2022

Interpretation

2. In this Variation Order, except where the context otherwise requires, the following expressions have the meanings respectively assigned to them:

“**the Principal Order**” means COTSWOLD DISTRICT COUNCIL (OFF-STREET PARKING PLACES) ORDER 2018;

3. Except where the context requires otherwise, any reference in this Order to an Article or Schedule shall be construed as a reference to that Article or Schedule in this Order
4. Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended, applied, consolidated, re-enacted by or as having effect by virtue of any subsequent enactment
5. The Interpretation Act 1978 shall apply for the interpretation of this Order

PART II

Amendment of the Principal Order

6. Article 24.3 shall be deleted and substituted with the following words:
24.3 the vehicle is not a Disabled Persons' Vehicle exhibiting in the Relevant Position a valid Disabled Persons Badge
7. Column 7 of The First Schedule to the Principal Order ("SCALE OF PARKING CHARGES") shall be amended as set out in the First Schedule of this Variation Order
8. The First Schedule of the Principal Order shall be amended in relation to row 5 ("5. CIRENCESTER, The Forum") so that Column 6 (MAXIMUM PERIOD WHICH VEHILCES MAY WAIT DURING THE CHARGING HOURS) shall read: "*3 Hours; Disabled Persons Vehicles may park for up to 10 hours*"
9. The First Schedule of the Principal Order shall be amended in relation to row 13 ("13.STOW ON THE WOLD, Maugersbury Road") Parking Place:
 - a. So that Column 2 ("POSITION IN WHICH VEHICLE MAY WAIT") shall read: "*Wholly within a Parking Bay (Marked for the relevant class of vehicle where relevant)*"
 - b. So that Column 3 ("CLASSES OF VEHICLE"), shall read : "*Motor Cars / Motor Cycles / Coach / motor home / caravan*"
 - c. By the deletion of the following words in Column 7 ("SCALE OF PARKING CHARGES"), : "*Coach, minibus, campervans parking free in markod bays*"
 - d. By the deletion of that part relating to Coach / motor home / campervan only, those parts as reproduced for reference in the the Second Schedule of this Variation Order
10. The First Schedule of the Principal Order shall further be amended by:
 - a. the deletion of that part of row 2 relating to Electric Vehicles only ("2. CIRENCESTER, Beeches Road Cont.") and of that part of row 12 relating to Electric Vehicles only ("12.MORETON-IN-MARSH, Old Market Way cont.) those parts as reproduced for reference in the Part A of the Third Schedule of this Variation Order
 - b. the insertion of the words as a fourth supplementary row as set out in Part B of the Third Schedule of this Variation Order

PART III

Full Force and Effect

11. Save as varied by paragraphs 6, 7, 8, 9 and 10 this Order the Principal Order shall continue in full force and effect
